FEATURES AND CONDITIONS OF OPTIMIZATION THE ENTERPRISES'S FINANCIAL STATE IN THE TERMS OF WAR

Abstract. The article examines key factors affecting the operation of Ukrainian businesses in times of war. It provides a comprehensive overview of the peculiarities and strategies for optimizing the financial state of enterprises in wartime conditions. Practical measures for managing the financial condition are proposed, which are an important aspect of ensuring successful business operations in modern realities.

The modern specificity of conducting business in Ukraine entails adaptation to operating in conditions of constant instability. Uncertainty complicates the process of economic activity planning. Despite instability, the financial condition of a business is influenced by a number of other factors: loss of capital and markets, disruption of logistic chains, decrease in activity, investment labor market complications, reduced purchasing power, and inflation rate growth.

In such conditions, all business entities should devote as much attention as possible to financial planning and risk management. Enterprises need to urgently analyze their financial capabilities, determine priority areas of activity, reduce costs, and rationalize business processes. In terms of finance, it is important to ensure effective management of financial flows and control over cash movement.

Components of financial management should be adjusted for increased risks. In the field of asset management, the focus should be on optimizing the structure of retained assets. Profit management should involve maximizing profits by reducing non-operating expenses. Cash flow management is crucial, as it should ensure an adequate amount of funds to continue entrepreneurial activities despite possible liquidity crises. One of the

most important components of financial management in wartime realities is risk management. Financial risk management involves avoiding risks and creating reserves to mitigate their impact in case of realization.

In addition to traditional methods of managing financial condition, business entities can take additional measures and utilize alternative sources of funding in the form of government assistance. Thanks to the 5-7-9% program, SMEs and entrepreneurs individual have the opportunity to obtain loans or open credit lines for working capital replenishment or investment purposes at 5, 7, and 9% interest rates with full or partial compensation of interest expenses by the state to financial institutions. The state continues to support businesses through a grant system, allowing individual

entrepreneurs or legal entities to receive funds for business development. The YeRobota program includes grants for 'Own Business', 'Garden', 'Greenhouse', 'Processing Enterprise', and 'Grants for Veterans and Their Families'. The Office for Entrepreneurship and Export Development has launched a series of initiatives to help business entities maintain the level of generated cash flows during wartime: 'The Supply Chain Resilience platform' (the platform was created to overcome supply chain disruptions caused by Russia's open military), 'Ukrainian Food Platform' (the first Ukrainian marketplace oriented towards selling prepared food to foreign markets), 'Do Business With Ukrainians' (the platform seeks and offers international customers verified Ukrainian companies and assists domestic entrepreneurs with knowledge, connections, training, and mentoring).
