## ESSENCE AND CONSEQUENCES OF THE SHADOW ECONOMY: ECONOMIC AND LEGAL ASPECT

**Abstract.** The article is devoted to the study of the essence and consequences of the shadow economy in the economic and legal aspect. The main approaches to defining the concept of "shadow economy", its factors, structural components and negative impact on society are considered. The mechanisms of combating the shadow economy and the possibilities of their application are analyzed. Some directions for improving the investment climate and business environment in Ukraine, bringing the economy out of the shadows are proposed.

It is determined that the shadow economy can take various forms, including illegal activities (for example, drug

trafficking), hidden economy (such as understatement of income by enterprises) and other aspects.

The article also describes the complex interrelationships between factors that lead to the spread of the shadow economy, including imperfect legislation and its inconsistency with real economic conditions, as well as violations of legal norms and a low level of institutional trust.

The article highlights the serious consequences of the shadow economy, such as a decrease in state budget revenues, which complicates the financing of social programs, the deterioration of working conditions and competitiveness, as well as contributing to social inequality and economic injustice.

The conclusions of the article emphasize the importance of a comprehensive approach to combating the shadow economy, including legislative improvements, greater financial transparency, stricter oversight of economic activity, and incentives for legal entrepreneurship. The effectiveness of the fight against the shadow economy largely depends on the interaction of the state, business, and the public. Given modern challenges, particularly the consequences of martial law, de-shadowing of the economy is one of the key tasks for ensuring Ukraine's sustainable development and economic security.
